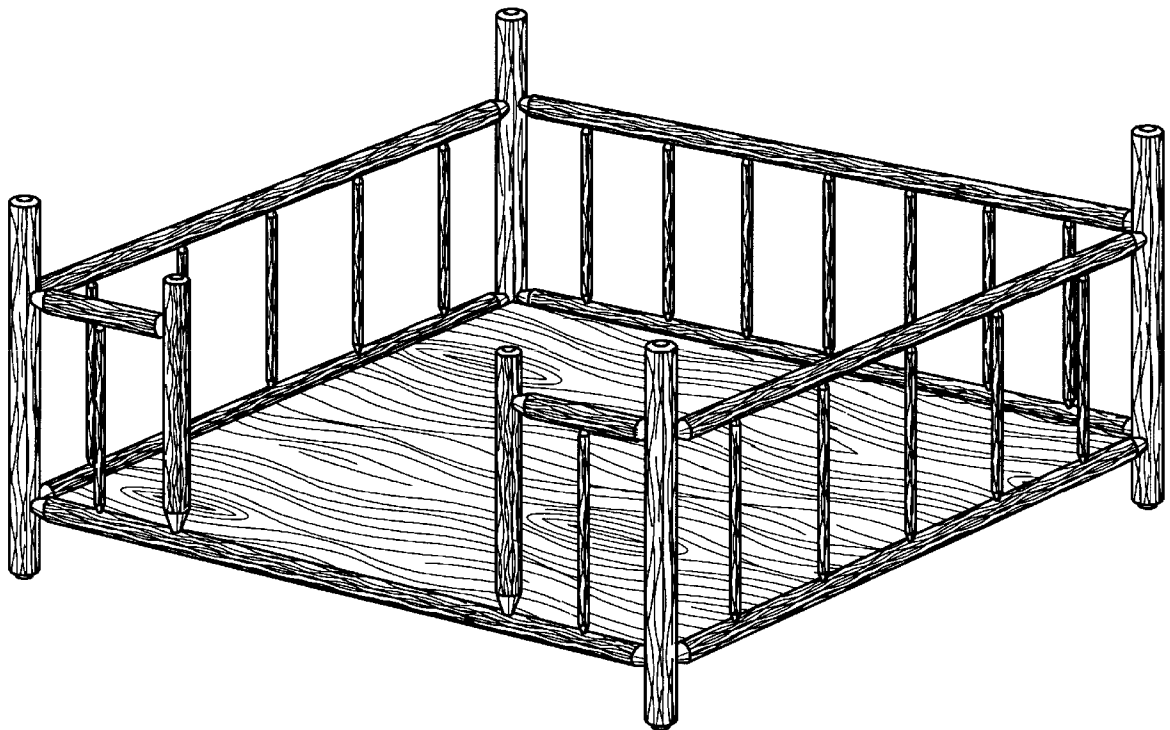
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a pet bed showing our new design; FIG. 2 is a rear view thereof; FIG. 3 is a side view thereof of the design of FIG. 1; FIG. 4 is a bottom view thereof of the design of FIG. 1; FIG. 5 is a top view thereof of the design of FIG. 1; and, FIG. 6 is a perspective view thereof of the design of FIG. 1.

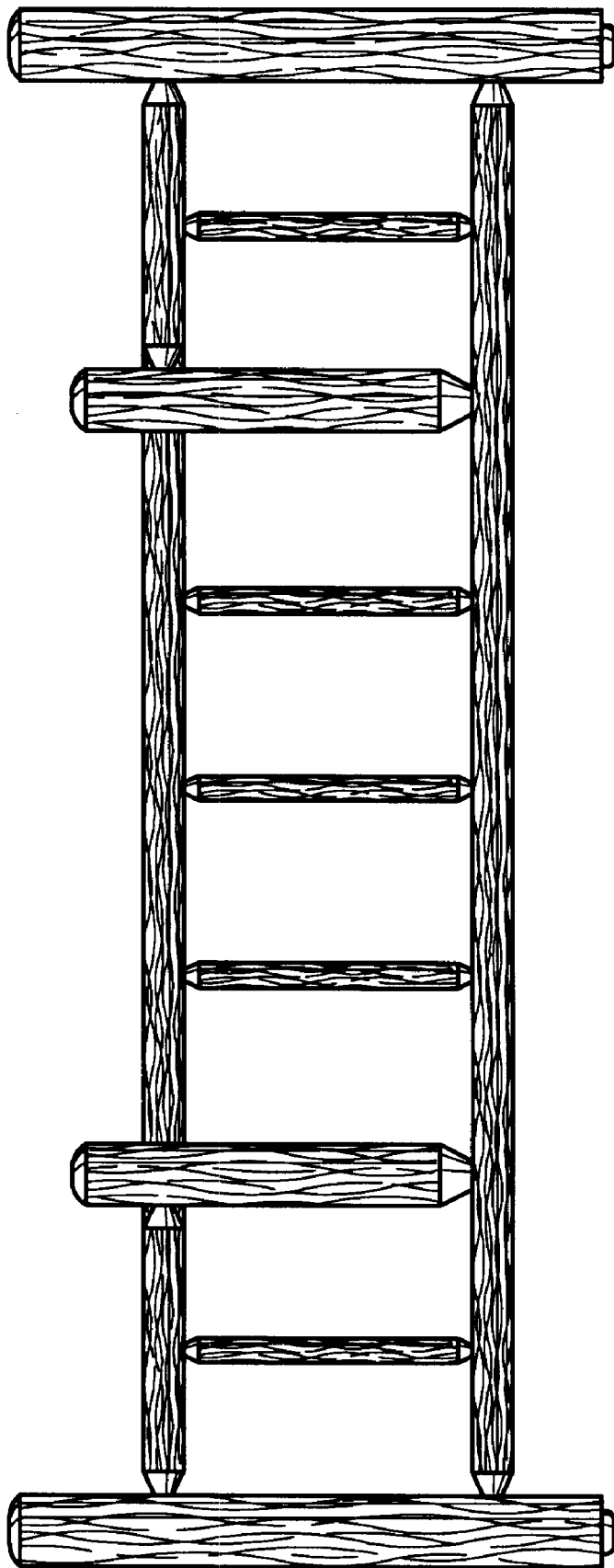

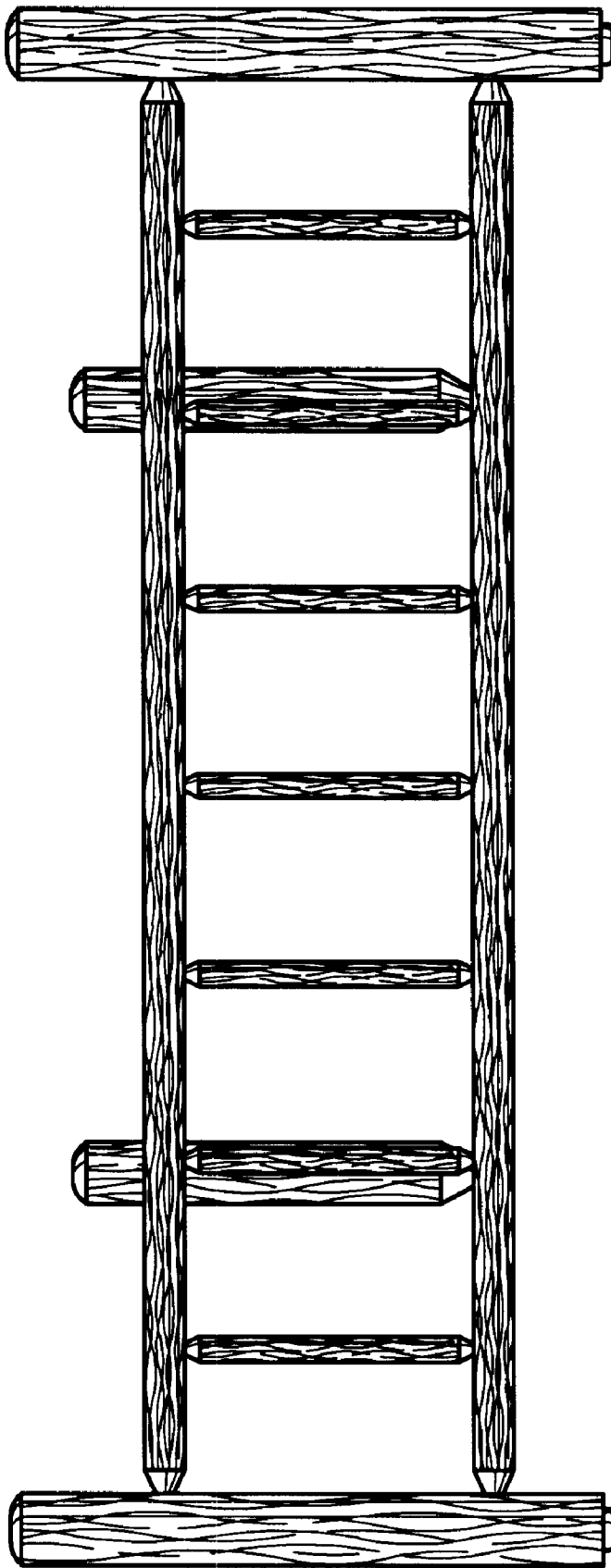

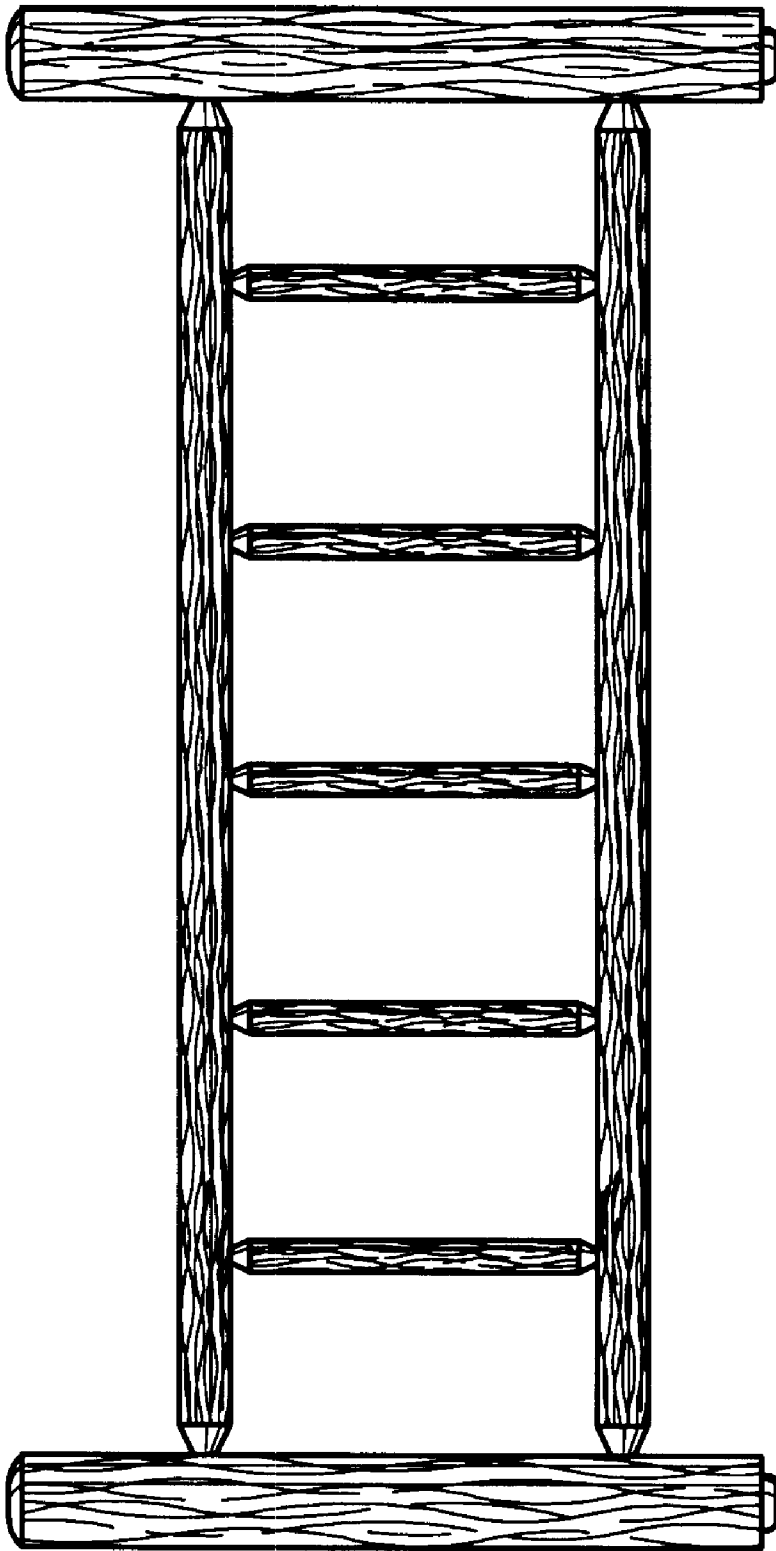

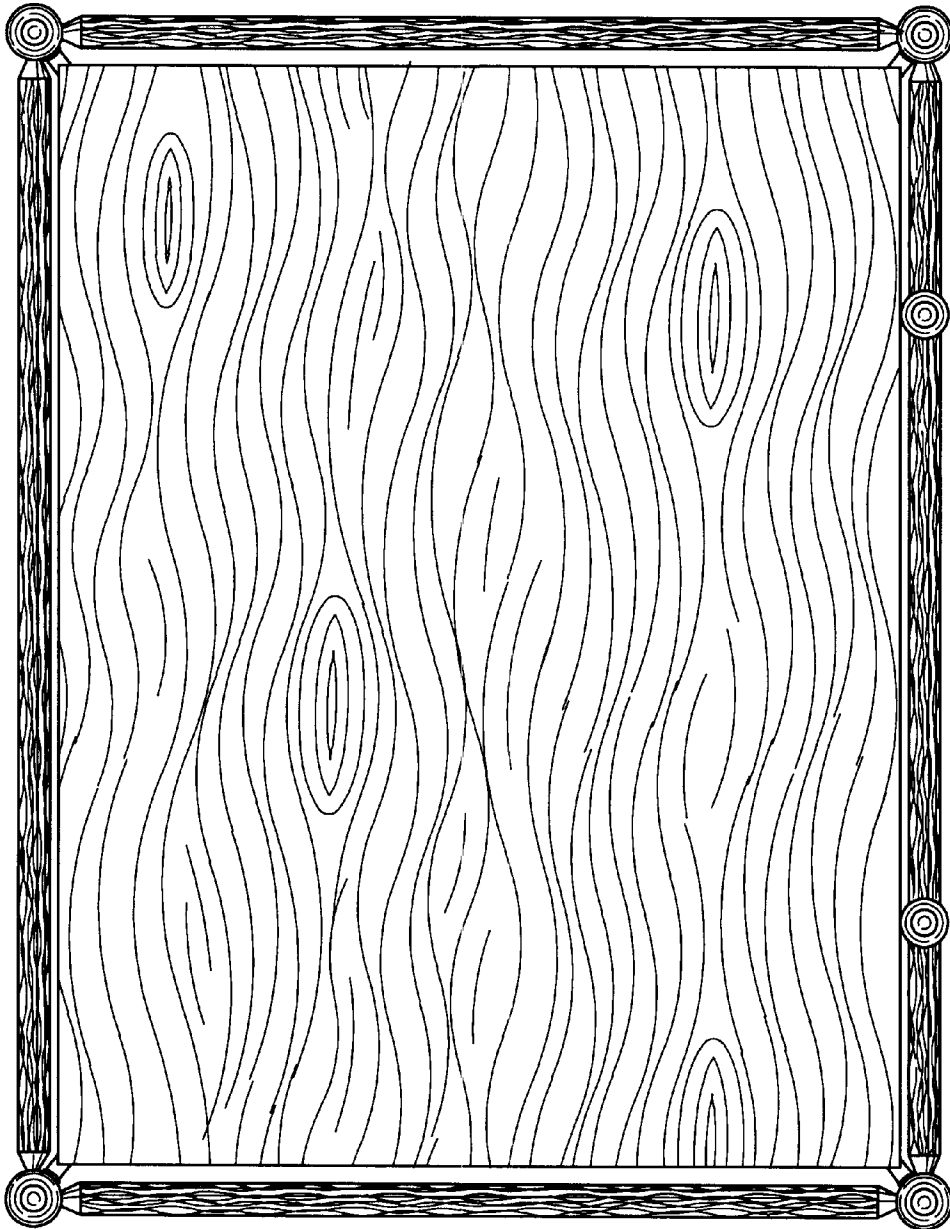

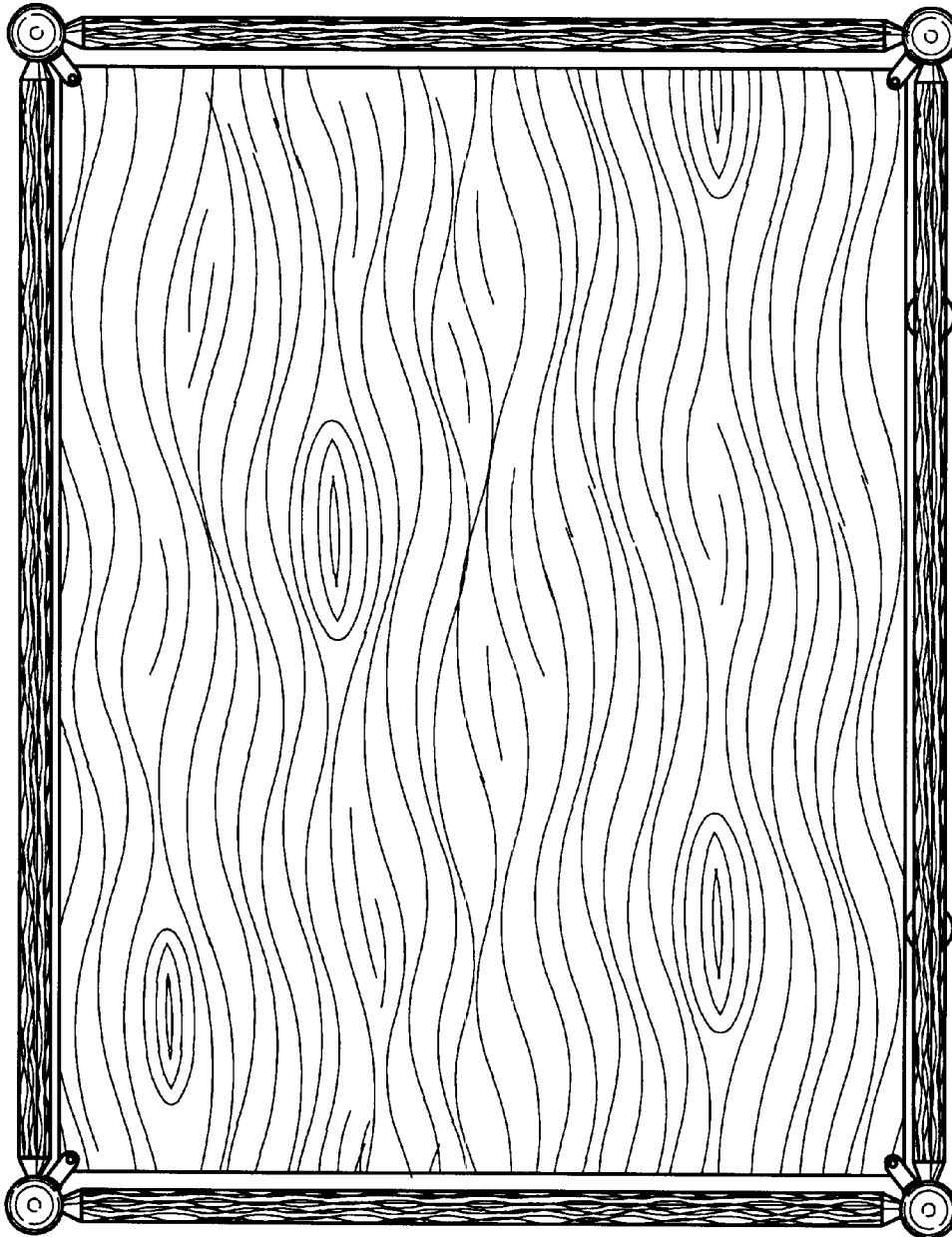

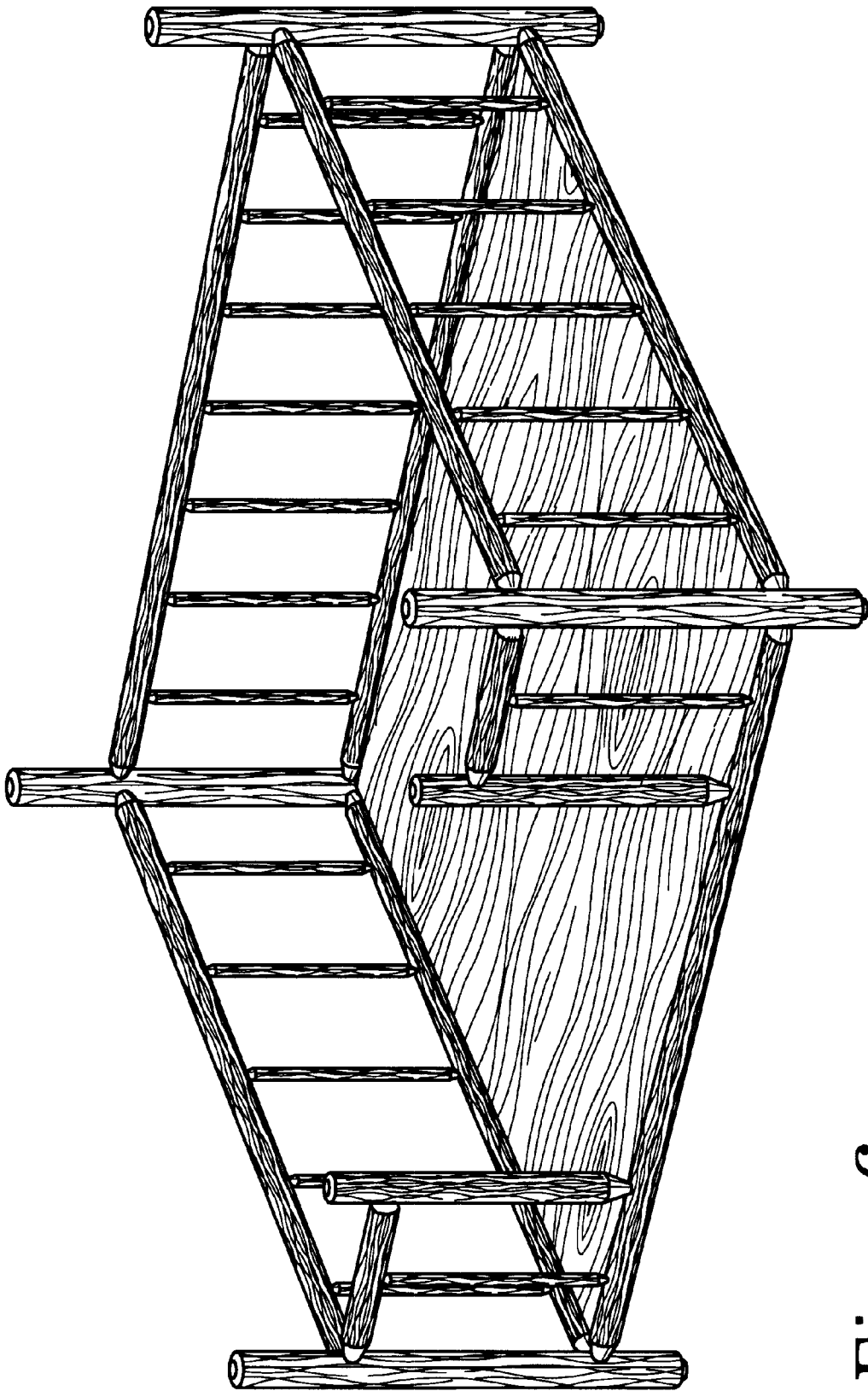
