DESCRIPTION

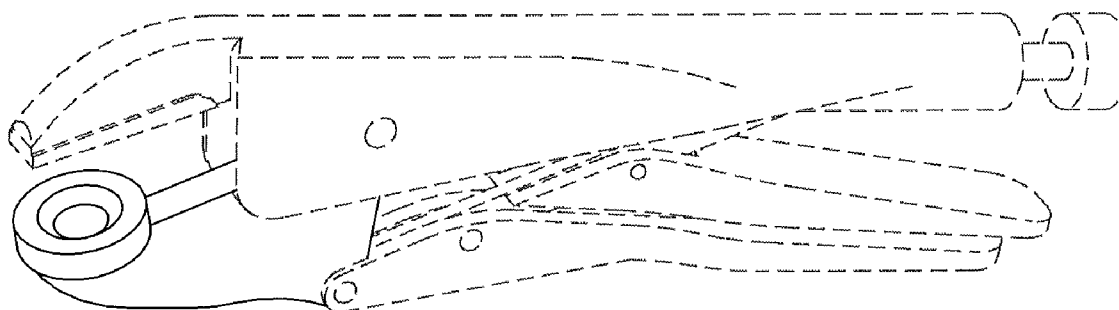
FIG. 1 is a perspective view of a clamp device showing my new design;

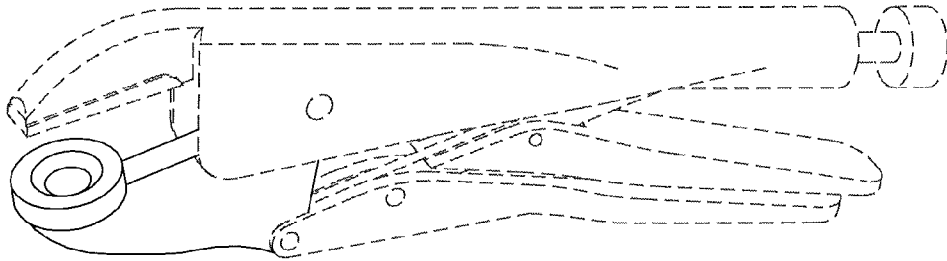

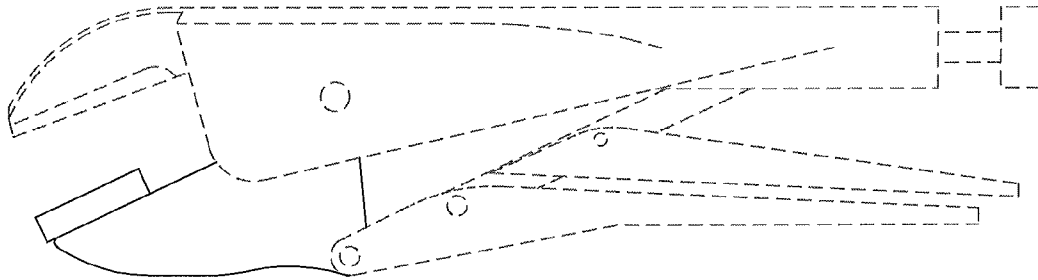

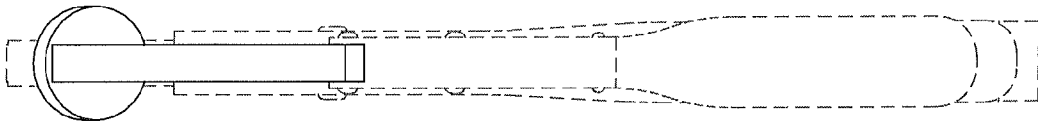
